1. Approval of February 25, 2021 Minutes – vote

Cindy Yulich moved and Kristen Flory seconded approval of the February minutes. Minutes were unanimously approved.

Cindy presented the first quarter financials and said Peaslee financials are consistent, over budget a little compared to that of 2020. The grants received reflected in the academic income of Peaslee. Angela then presented the 2021 audit and the 990 report. Angela talked about the long-term debt of Peaslee, and that Kevin decides bad debit, which there were some in 2020 due to API foils. Peaslee should not be too effected by the effects of COVID-19. Angela reported that 990s are required for a nonprofit and Peaslee has great commands on funds. Craig moved on the audit; Shannon seconded. Unanimously approved. Lisa moved on the 990, Taylor seconded. Unanimously approved on the 990.

3. Academic Committee

Kevin present, saying a goal of Peaslee's was a fully function quality program, in which Peaslee hired Riq Quinteros to take input from student observations and give report to instructors to give the best quality for students. Student evidence base is important for quality. Kevin stating Riq Quinteros gave a presentation about using observations for the facilitators to improve quality.

4. Planning Committee

Kevin reported that there will be a new entrepreneur hub in Peaslee to help small business start up called Crunch. This development center will allow Peaslee students to be able to help build and help in this project start up. In the first year, Peaslee hopes to help 50 individuals get started in a business or existing small businesses. The bus stops the Carpentry students built last year, will be around Lawrence by the 1st of July.

5. 2021-2026 Strategic Goals - vote

Kevin presents the goals for the next five years. Kevin presented that 66% of the RISE Douglas County CARES fund participants were those of low-income family and 45% were of BIPOC Communities. Long term goal would be to reach 26%, which is double that of the Douglas County population of low-income families to be able to train at Peaslee Tech. There was a new funding of \$50,000 for the HVAC and Plumbing course for the who indicate from the BIPOC community. The goal is to work and serve in Peaslee diversity, recruit and retain staff, instructors, and board members from BIPOC communities. Another goal was to support business here



and that we are meeting their needs. Fully develop Entrepreneur center to provide documented support for aspiring entrepreneurs and existing small business. Lastly to have more of an awareness to Peaslee Tech. That 50% are aware of Peaslee across all organizations. Cindy moved, Marilyn second. Goals were unanimously approved.

6. Introduction of Diversity, Equity, & Inclusion Facilitator – George Crump

Shirley introduced George Crump as the Diversity, Equity, and Inclusion Facilitator. George's role is to review Peaslee's documents and policy procedures and how Peaslee can do those differently.

7. Anti-poverty Plan of Douglas County Health Plan – Jill Jolicoeur

Hugh Carter reported they had a specially called meeting with the board and Jill Jolicoeur present the Antipoverty plan. The hope for Peaslee to train in early childhood education pathway. Decision to go more in-dept next board meeting.
